#### **ELIGIBILITY**

Youth between the ages of 0-12 are eligible to participate in the Youth Summer Saving Program. Persons must have a US SSN/ITIN to receive prize. To be automatically entered into the drawing, entrant must begin a Savings Map and turn the stamped map in to one of the above listed A+FCU branch offices during regular business hours. A+FCU employees, employee household members and Board Members of A+FCU are not eligible. No purchase required.

### Savings Maps:

- For each in-person deposit (\$1 or greater) members age 0-12 make to their A+FCU savings account from June 10 – August 10, member will move one space on their saving map. Member will turn in their savings map, which will then be entered into the drawing. Members will earn one entry per deposit; if 10 deposits are made on a single map, members will earn an additional 2 bonus entries per map submitted.
- Limit one deposit per day.
